

Installment Agreement (2X,3X,4X)

1. Payment by Instalments is a payment facility provided to you ("You") by Corsair S.A.S. ("Corsair" or "we") pursuant to this Agreement ("the Agreement"), which specifically governs your use of Payment by Instalments, and Corsair S.A.S.'s General Terms and Conditions of Sale and Carriage.

2. The "Installment Plan" is a payment facility that allows you to pay, free of charge (0% APRC), in two, three or four installments, for Eligible Purchases that you have made on Corsair's website "flycorsair.com".

An initial payment is made at the time of purchase, followed by installments up to 89 days from the date of enrolment. The number of installments offered at the time of purchase will depend on the date of your flight, with full payment required seven (7) days prior to departure.

3. Pursuant to Article L. 312-4 of the French Consumer Code, "Payment in installments" is not regulated by Chapter 2 "Consumer Credit" of the French Consumer Code, as its duration does not exceed three months and it is free of charge. Consequently, you acknowledge and accept that the "Payment in installments" offered by Corsair is not covered by the French consumer credit regime and that Corsair does not subject the "Payment in installments" to this regime.

4. Payment by Instalments" is available to individuals over 18 years old, who have a valid bank card (Carte Bleue, Visa, Amex, Mastercard) linked to a funded account for the duration of the repayments to be made under "Payment by Instalments". Payment in installments is only available for bookings in euros (€).

This agreement is available at any time on the Corsair website.

6. Acceptance and entry into force of these terms and conditions

During the purchase process on the "flycorsair.com" website, and if your purchase is eligible, you may choose the "Payment in Installments" payment method and select the number of installments required from the proposed installments by clicking on the button. Please note that not all bookings are eligible for payment in installments and that the number of installments proposed will be automatically adjusted to allow for full payment of the booking seven (7) days prior to departure.

By clicking on one of the options in the "Payment in Installments" section, you will be redirected to Corsair's Payment in Installments page.

You will then be able to view all the relevant information regarding the installment option and confirm that you wish to proceed by clicking on the "Proceed to Payment" button.

Your acceptance of the Agreement is confirmed by ticking the box "I accept the terms of the Installment Agreement and the recording of my payment details for future direct debits", linked to the acknowledgement of Corsair's General Terms and Conditions of Sale and Carriage and the acceptance of the Agreement. Acceptance of this Agreement constitutes a contract between the parties within the meaning of Article 1103 of the French Civil Code.

By accepting the terms of the Agreement, you expressly agree that performance of the Agreement shall begin immediately upon your acceptance.

You are obliged to repay the amount of the credit in accordance with the repayment schedule agreed at the time of the transaction.

You have a withdrawal period of 14 calendar days from the conclusion of the Agreement.

To the extent that the 14-day cooling-off period does not apply to distance contracts for the carriage of passengers, in accordance with article L221-2 of the French Consumer Code and article 20 of Corsair's General Conditions of Sale and Carriage, you may exercise your right of withdrawal only with respect to the installment contract and not with respect to the reservation.

Consequently, if You exercise your right of withdrawal, You must pay for your ticket immediately. If you fail to pay the outstanding amount, your reservation will be automatically cancelled. Any instalments already paid will remain due to Corsair and no refund will be made. In this case, no amount may be claimed for airport taxes.

7. Each refund is automatically debited from the credit card whose registration you have accepted with our payment service provider Monext on the due date of each payment. We will send you a reminder the day before each due date.

You can also repay in advance the outstanding balance at any time, free of charge. To do so, please click on the "status of your monthly payments" link in the e-mails that Corsair sends you in connection with payment in instalments.

If Corsair attempts to debit your credit card for the repayment of an installment and is unsuccessful, we will send You every day until the payment is regularized, and within a maximum of seven (7) days an e-mail containing a link allowing You to regularize the payment of the installment.

If the credit card used for repayment changes or expires during the term of the loan, you will be able to change the credit card used for repayment by clicking on the "status of your monthly payments" link in the e-mails sent to you by Corsair in connection with payment in instalments.

8. Failure to pay any installment within seven (7) calendar days will result in automatic termination of this Agreement and the contract of carriage with Corsair. Any instalments already paid will remain due to Corsair and no refund will be made. In this event, no amount may be claimed for airport taxes.

9. If You proceed with a modification of your tickets and modification or fare readjustment fees are applied, these fees will be immediately payable. They cannot be added to the existing schedule. In the event of a change to a lower fare, the fare difference will not be refunded to You in accordance with article 1.2.3 of Corsair's General Conditions of Sale and Carriage.

In the event of a change to the departure date, and only if the new departure date does not allow payment of the installments seven (7) days before departure, Corsair will cancel the remaining instalments and immediately debit the outstanding amounts from the credit card used for the purchase in order to guarantee full payment of the reservation before departure.

10. If you cancel your purchase on the Corsair flycorsair.com website, in accordance with Corsair's General Conditions of Sale and Carriage, we will refund you according to the fare conditions of your tickets. If the fare conditions of your ticket do not allow a refund, or if the instalments already paid do not cover the cost of cancelling your ticket, Corsair will charge the outstanding amount to your credit card.

11. If You pay more than You owe us, we will refund to Your credit card. Similarly, if Corsair makes a refund to Your credit card and it later turns out that You were not entitled to this refund, Corsair reserves the right to recover this refund by debiting Your credit card.

12. We cannot be held responsible if You are unable to access the payment facility option or if we are unable to enforce any of our obligations under these terms and conditions, pursuant to applicable law or regulation, in the event of abnormal and unforeseeable circumstances beyond our reasonable control, the effects of which would have been unavoidable despite our best efforts.

13. Any notification sent in application of this Agreement will be sent to the e-mail address indicated at the time of your purchase on the Flycorsair.com website.

14. This Agreement is governed by French law.

In the event of a dispute concerning the interpretation or performance of this Agreement, or the consequences thereof, the Parties undertake to make every effort to reach an amicable settlement.

Failing amicable settlement within eight (8) days, the dispute will be submitted to the Commercial Court of Paris, France.
